The following paragraph is from the I.R.S. regulations:
See form 8383 Internal Revenue Services-Charitable Contributions:
Requires that the contributor attach to his income tax return the following information:

1. Name and Address of the organization to which the contribution was made.
2. Date of the contribution
3. Description of the property, including its condition
4. Cost of the property
5. Fair market value showing method of utilized in determining fair value
6. Amount claimed as a deduction

Additional information is for any single item contribution for which a deduction is in excess of $\$ 500.00$ is claimed. Check with you local I.R.S. office in such incidents.
